The Exceptional Family Member Program (EFMP) was established in 1987 to assist active duty service members in providing for the special needs of their Exceptional Family Members before, during and after relocation required by a change of duty assignment.

An Exceptional Family Member is defined as any authorized family member (spouse, child, stepchild, adopted child, foster child or dependent parent) residing with the sponsor who possesses a physical, intellectual or emotional disability and requires special medical or educational services. The program ensures every attempt is made to mesh military career and special family needs whenever possible.

If you have an Exceptional Family Member, enrollment in the EFM program is **mandatory** as per MCO P1754.4A. The aim of the program is to help monitors at Headquarters Marine Corps assign Marines to locations where exceptional family member special needs can best be met. Additional services include the following:

- SPECIAL MEDICAL / EDUCATIONAL NEEDS ADVOCACY
- REFERRALS TO AVAILABLE LOCAL RESOURCES
- ASSISTANCE IN LOCATING APPROPRIATE CHILD CARE
- PRIORITY HOUSING FOR ELIGIBLE FAMILIES
- LENDING LIBRARY WITH BOOKS AND VIDEOS

Active duty personnel are still deployable but you won't have to worry about getting a permanent change of station orders to an area where required medical or educational services are not available to your family member.

Enrollment can be for as long as necessary. According to MCO P1754.4, enrollment and enrollment updates are the responsibility of the active duty military member. Disenrollment requires a letter from a medical doctor stating that the diagnosis or condition has resolved and the family member no longer receives services. Disenrollment can also take place if there is a change in marital status or if a minor child turns 18 or 21 and no longer lives with the active duty member. Once enrolled, as the Marine sponsor, you will be assigned one of the following categories:

Category 1: Needs generally do not limit assignment.

Category 2: Pinpoint assignment overseas and continental US.

Category 3: No overseas assignment.

Category 4: Major medical areas in continental US.

Your category reflects several factors: Your family member's diagnosis, the severity of the diagnosis, available medical/educational/psychiatric resources at each duty station, and the expected duration of the diagnosis. For example, the Marine Corps would not want to send a Marine on an accompanied tour of say, MCAS Iwakuni when that Marine's family member had congestive heart failure. Local resources might be unable to support that family member at all or might be unable to treat all aspects of the family member's illness.

### **SOME THINGS EFMP DOES NOT HAVE RESPONSIBILITY FOR COMPLETING:**

**Humanitarian Transfers (HUMS):** While a Marine may have a family member enrolled in EFMP and also apply for a HUMS, the two programs are separate. For more information on HUMS and the process it takes to qualify, please visit the following website:

Unlike EFMP, HUMS does require the involvement of your chain of command. In order to qualify, you must have documentation from your family member's medical provider(s), as well as the support of your chain of command. HUMS requests are granted only under specific circumstances.

**Hardship Discharges:** Similar circumstances (death of a spouse or major illness of a family member) may lead a Marine to seek either a HUMS or a hardship discharge. A hardship discharge also originates with the chain of command at the local installation, but must be approved through HQMC.

**Overseas Screening (OSS):** An OSS takes place whenever a Marine family has orders to a isolated duty (such as recruiting in Montana) or to an overseas installation (usually Okinawa or Iwakuni). OSS is the responsibility of the Military Treatment Facility both at the current installation and at the installation where the family may move. EFMP is only part of this process if the family is already enrolled or if the family has not previously enrolled but should due to a medical, educational, or psychological special need. In many Navy MTFs, the Navy EFMP coordinator and OSS screener are the same person. Marine Corps EFMP Coordinators are usually housed in MCCS Personal Services.
